### Mine Safety & Health Act (MSHA) Part 46.8

Employees involved in mining, including those working at gravel pits, are required to receive 8 hours of annual refresher training as outlined in the entity's written training plan. **These classes meet MSHA annual refresher training requirements.** 

#### **General Safety Training**

For those not required to comply with MSHA, be sure to review the training topics offered and consider sending your employees. A minimal investment of time may help your entity meet safety training goals, manage risks, and avoid work-related injuries. **These classes qualify for 5 contact hours toward Water/Wastewater Operator Recertification.**
